II. Purpose of Addendum

The purpose of this addendum is to determine if the reconfigured upstairs bedrooms are appropriate for resident use.

III. Methodology

IV. Description of Findings and Conclusions

On 4/29/21, the licensee designee, Kehinde Ogundipe emailed me to tell me that he reconfigured the upstairs bedrooms to provide for all private resident rooms. Originally, there were 3 bedrooms upstairs but only 2 of them were approved for resident use. Each of those 2 resident bedrooms were suitable for 2 residents. The 3rd bedroom was a staff bedroom. Mr. Ogundipe attached an updated floor plan which shows that he installed a wall in one of the multi-occupancy bedrooms to make an extra bedroom. He also requested that the staff bedroom be approved for resident use.

On 5/19/21, I conducted an onsite inspection of Welch Home Adult Foster Care facility. I reviewed the revised floor plan submitted by the licensee, Kehinde Ogundipe and inspected and measured the upstairs bedrooms. I determined that all upstairs bedrooms meet licensing requirements to be approved for resident use.

All upstairs bedrooms are identified by room numbers on the doors. The upstairs bedrooms were measured during my onsite inspection and they have the following dimensions:

#3	12'3" x 9'10"	120	1
#4	7'9" x 12'3"	95	1
#5	11'11" x 10'5"	124	1
#6	11'11" x 10'6"	125	1

V. Recommendation

I recommend that all the upstairs bedrooms be approved for resident use. The capacity of this small group home remains at 6. The downstairs bedrooms have not been reconfigured and are still suitable for 1 resident each.
