On 08/06/2021, licensee Shirley Talley requested that the terms of her family home license be amended to reflect that she is able and willing to care for female residents.


On 08/09/2021, I talked with licensee Shirley Talley who understood and agreed that only same sex individuals can share a bedroom unless they are a married couple. The facility currently has three male residents, so the facility does have room for female residents as the home's capacity is five. Additionally, all bedrooms in the facility are single occupancy except bedroom #3, which is 12'11" X 12'2" and 157.15 square feet therefore is large enough to accommodate two residents.

## IV. Description of Findings and Conclusions

On 08/09/2021, I talked with licensee Shirley Talley who understood and agreed that only same sex individuals can share a bedroom unless they are a married couple. Licensee Shirley Talley understands that bedroom #3, is the only bedroom large enough to accommodate two residents. Licensee Talley understands that it is her responsibility to not exceed the licensed capacity of five residents at any time.

## V. Recommendation

I recommend that female gender be added to the license.
