### II. Purpose of Addendum

#### IV. Description of Findings and Conclusions

On 10/13/21, I conducted an onsite inspection of Geralyn's Assisted Living. I inspected a bedroom that was previously not licensed or approved for resident use. The bedroom measures 10'8" x 11'5" for a total of 122 square feet. I also determined that the bedroom furnishings meet the requirements for resident use.

#### V. Recommendation

I recommend that the previously unlicensed bedroom (Bedroom #3) is approved for resident use. Therefore, the capacity of this small group home is increased from 3 residents to 4 residents.
