**II. Purpose of Addendum**

The purpose of the addendum is to add developmentally disabled, aged, and Alzheimer’s to the program type of Venetria Home and to change the age range to 35-95.

**III. Methodology**

09/10/2021 - I received a phone call from the licensee, Michelle Harrison, requesting to change the age range and population type for her licensed family home to include aged/Alzheimer’s, and developmentally disabled.

09/12/2021 - I received a revised program statement for Venetria Home.


09/28/2021 - I reviewed current license file, Licensee’s information in BITS, and revised program statement.

**IV. Description of Findings and Conclusions**

Based on the information received and documents reviewed, the licensee is able to provide services to the developmentally disabled, aged, and Alzheimer’s populations. Venetria Home is a licensed adult foster care family home. Ms. Harrison indicated that she will conduct a thorough assessment prior to accepting residents into the home to ensure that they are compatible with other residents and members of the household. The home is not able to accommodate residents who use wheelchairs.

**V. Recommendation**

I recommend that developmentally disabled, aged, and Alzheimer’s be added to the program type for Venetria Home and that the age range be changed to 35-95.
