**II. Purpose of Addendum**

Licensee James Hoeberling submitted a modification request on 9/18/2019 to change the age range from 50 to 18 years of age.

**III. Methodology**

On 9/18/2019, I reviewed the facilities program statement which was reviewed and approved by this consultant.

**IV. Description of Findings and Conclusions**

Based on a review of licensee designee James Hoeberling qualifications and documentation submitted, he meets the qualifications to provide care to individuals who are aged and/or diagnosed with mental illness.

A Ewing Country Estate AFC, Inc. will focus on care to individuals with mild to moderate mental illness that are between the ages of 18 to 99 years old. When residents require a greater level of care or supervision, then the staffing ratio will be modified to ensure safety. A Ewing Country Estate AFC, Inc. will assess for compatibility for all the residents that they provide care for and licensee James Hoeberling will recommend another setting if the facility is not equipped to meet the needs of a resident or as their symptoms and needs change.

**V. Recommendation**

I recommend that the age range be lowered to 18 years for A Ewing Country Estate AFC Inc.
