
IV. Description of Findings and Conclusions

Based on a review of her qualifications and documentation submitted, Ms. Glasscoe meets the qualifications to provide care to individuals who are mentally ill and/or developmentally disabled.

Loving Care and Comfort will focus on care to individuals with mentally illness and/or developmental disabilities. Loving Care and Comfort will help residents maintain their highest possible level of functioning, keep them active, alert, independent and content. This will be accomplished through a structured environment, assessment plans with realistic goals and well-trained compassionate staff.

V. Recommendation

I recommend that Mentally Ill and Developmentally Disabled program types are added to the license for Loving Care and Comfort and Aged program type is removed.
