ALLEGATION:

There are bed bugs in the home.

INVESTIGATION:

On 9/29/2021, I received this complaint through the Bureau of Community and Health Systems online complaint system. This complaint alleged there are bed bugs in the home.

On 10/4/2021, I conducted an interview with Adult Protective Service Specialist (APS) Madeline Wirgau. Ms. Wirgau stated this facility has been having issues with bed bugs for several years and believes the issue has yet to be resolved.

On 10/05/2021, I conducted an interview with AFC Licensing Consultant Eli Deleon who stated he conducted inspections in the past to investigate bed bug allegations and found that Mr. Bairagee implemented treatment programs to manage the infestation of bed bugs by using sprays, powder, and foggers that the licensee purchased from the store.

On 10/05/2021, I reviewed SIR #2021A1030013, SIR #2019A0578026, and SIR #2018A0578044 which all stated that licensee Probir Bairagee has been managing infestation of bed bugs on his own with the same method and course of action by using sprays.

On 11/16/2021, I conducted an onsite investigation at the facility with licensee Mr. Bairagee. Mr. Bairagee stated he has been having issues with bed bugs for about 4 years and he has been able to control this issue however he has not been able to eradicate the problem. Mr. Bairagee stated he uses products purchased from the store such as sprays, powders, and foggers to treat the bed bugs. Mr. Bairagee stated he has asked Community Mental Health to assist with the cost of treating the bed bugs as it is becoming costly to continue to purchase products from the store. Ms. Bairagee stated he believes he continues to have issues with bed bugs in his home because some residents purchase items from local nearby thrift stores and they are not checking the items to ensure these items are free from bugs. Mr. Bairagee stated he usually has bed bug issues in the spring at which time he will spray to get rid of them however the bed bugs will unfortunately come back about two weeks later. Mr. Bairagee stated Resident A complained about being bit by bed bugs recently and another resident complaint about a month ago. Mr. Bairagee stated he sprays whenever he gets a complaint from a resident and sprays regularly as a precaution. Mr. Bairagee stated he has not implemented alternative measures to treat bed bugs because professional services can be costly. It should be noted Mr. Bairagee is open to exploring professional pest control programs to the treat the bed bugs in the home as an alternative measure.

While at the facility I also interviewed Residents A, B, and C. Resident A stated he has seen bed bugs currently and gets bitten "all the time". Resident A further stated he has been living in the home for a year and has been dealing with bed bugs in his bed since his admission. Resident A stated he believes the issue is getting better however the bed bugs are still present. Resident A further stated he has observed Mr. Bairagee spray and use powders in attempts to treat the bed bugs.

Resident B stated he has been living in the home for 10 years and he has seen bed bugs in the past however has not had any issues with bed bugs currently.

Resident C stated she has been living in the hone for 6 years. Resident C stated there are some issues with bed bugs in the home however the problem is getting better because she last saw a bed bug a couple of weeks ago. Resident C stated she has noticed that bed bugs "come and go" and Mr. Bairagee uses sprays and powders to try to treat them.

ALLEGATION:

Resident A is not able to rely on staff to pick him up when volunteering in the community.

INVESTIGATION:

On 10/12/2021, I received additional allegations through the Bureau of Community and Health Systems online complaint system which stated Resident A is not able to rely on staff to pick him up when volunteering in the community.

On 11/16/2021, I conducted an onsite investigation at the facility with licensee Probir Bairagee regarding this allegation. Mr. Bairagee stated Resident A is allowed to go out independently in the community without supervision and Resident A does not report to hm on his whereabouts. Mr. Bairagee stated he is not responsible to provide transportation to Resident A except for medical appointments and grocery shopping in the local area. Mr. Bairagee stated Resident A often goes out in the community with various friends and has been returning to the home past curfew which is a house rule that Mr. Bairagee has in place. Mr. Bairagee stated he has talked with Resident A's mental health worker regarding Resident A's behavior and has issued a 30-days discharge notice to Resident A due to Resident A not adhering to curfew house rules and behaviors of stealing. Mr. Bairagee stated Resident A is working with his mental health worker to find alternative placement at this time.

I also conducted an interview with Resident A. Resident A stated he does all his personal care independently on his own and does not require any supervision when out in the community. Resident A stated he is living in an adult foster care home to receive meals and administration of his medication. Resident A stated the home is only responsible to provide transportation for medical appointments therefore Resident A relies on friends to take him in the community when he volunteers at various locations. Resident A stated he often volunteers in Niles, MI. Resident A stated he does not have any issues with the transportation services at the home. Resident A further stated he is planning on applying for various jobs and he has transportation in place from friends.

While at the facility, I reviewed Resident A's *AFC-Resident Care Agreement* (agreement) dated 10/30/2020. According to this agreement, Mr. Bairagee is responsible transportation to medical appointments or shopping in Three Rivers, Centerville, and White Pigeon. The agreement stated Resident A can pay extra cost in the amount of \$20 for transportation for any kind of trip to Kalamazoo, Sturgis or more than 20 miles. The agreement further stated Resident A will inform staff before leaving the home.

	(5) At the time of resident's admission, a licensee shall complete a written resident care agreement which shall be established between the resident or the resident's designated representative, the responsible agency, and the licensee. A department form shall be used unless prior authorization for a substitute form has been granted in writing by the department. A resident shall be provided the care and services as stated in the written resident care agreement.		
ANALYSIS:	Based on my investigation which included interviews with licensee Probir Bairagee, Resident A, review of Resident A's <i>AFC-Resident Care Agreement</i> there is no evidence to support the allegation Resident A is not able to rely on staff to pick him up when volunteering in the community. Both Resident A and Mr. Bairagee stated Resident A does not require supervision in the community and Mr. Bairagee is not responsible for transportation to Resident A outside of medical appointments. According to the resident care agreement, Mr. Bairagee is required to provide transportation to Resident A to medical appointments or shopping in Three Rivers, Centerville, and White Pigeon. The agreement also stated Resident A can pay extra cost in the amount of \$20 for transportation for any kind of trip to Kalamazoo, Sturgis or more than 20 miles. Resident A stated he relies on friends to provide him transportation when he volunteers and likes to volunteer in Niles, MI. Resident A also stated he has not had any issues with transportation services in the home. Resident A is provided the services as stated in the written care agreement.		
CONCLUSION:	VIOLATION NOT ESTABLISHED		

ADDITIONAL FINDINGS:

INVESTIGATION:

While at the facility, Mr. Bairagee was not able to provide an Assessment Plan for AFC Residents (assessment plan) for Resident A. Mr. Bairagee stated Resident A's assessment plan has yet to be completed by Resident A's mental health provider therefore he does not have the plan in his home. Mr. Bairagee stated he usually completes the assessment plan with the resident's responsible agency however

when Resident A was admitted last year in 2020 the mental health worker did not return the assessment plan back to him and he failed to follow-up with the worker regarding this matter.

	(2) A licensee shall not accept or retain a resident for care unless and until a resident assessment plan is made and it is determined that the resident is suitable pursuant to the following provisions:		
	(a) The amount of personal care, supervision, and protection required by the resident is available in the home.		
	(b) The kinds of services and skills required of the home to meet the resident's needs are available in the home.		
	(c) The resident appears to be compatible with other residents and members of the household.		
ANALYSIS:	While at the facility, Mr. Bairagee was not able to provide a resident assessment plan for Resident A. Mr. Bairagee stated Resident A's assessment plan has yet to be completed by Resident A's mental health provider therefore he does not have the plan in his home. Mr. Bairagee stated he usually completes the assessment plan with the resident's responsible agency however when Resident A was admitted last year in 2020 the mental health worker did not return the assessment plan back to him and he failed to follow-up with the worker regarding this matter. Mr. Bairagee accepted Resident A in his home without completing an assessment plan to determine if Resident A is suitable.		
CONCLUSION:	VIOLATION ESTABLISHED		

On 11/17/2021, I conducted an exit conference with licensee Probir Bairagee and informed Mr. Bairagee of my findings. I allowed hm an opportunity to ask questions and make comments.

On 11/17/2021, I received and approved an acceptable corrective plan.

IV. RECOMMENDATION

I received an acceptable corrective action plan therefore I recommend the current license status remain unchanged.
