## **II. Purpose of Addendum**

The corporation Grand B1, Inc. which was previously owned by Alan and Tamara Sisco was sold to Edward and Linda Powell on May 24, 2021 and a request was made by Edward Powell to change the controlling ownership interest for the corporation, Grand B1, Inc.

## **III. Methodology**

On May 24, 2021, I received correspondence from the previous owner, Tamara Sisco stating Grand B1, Inc and Sisco Leisure Living was sold to Edward and Linda Powell and the EIN number would stay the same.

On July 14, 2021, I received verification of Mr. and Mrs. Powell's experience, updated home policies, record clearance, and medical clearance including tuberculosis testing and results, verification of training, and a new *Adult Foster Care application (BCAL 569-C)* with the new facility name of Grateful Hearts AFC.

The application reflects Mr. Edward Powell as the licensee designee for Grateful Hearts AFC.

On July 21, 2021, I reviewed the Department of Licensing and Regulatory Affairs website and verified that the Resident Agent is now Edward Powell as of June 30, 2021.

## **IV. Description of Findings and Conclusions**

On May 24, 2021, Edward Powell purchased the Grand B1, Inc. and assumed the duties of licensee designee and administrator of this facility. The address of the facility will remain the same at 6523 North Sheridan Road, Edmore, MI 48829. The EIN number remains intact the AFC license number remains AM590269332.

I have received verification of Mr. Powell's record clearance with fingerprints, training, medical clearance including tuberculosis testing and results and a completed corporate application.

**V. Recommendation**

The Department accepts Edward and Linda Powell's request to change the name to Grateful Hearts AFC and Edward Powell will remain the licensee designee of the facility.
