This facility was found to be in non-compliance with the following rules:

R 400.14310	Resident health care.
	(3) A licensee shall record the weight of a resident upon admission and monthly thereafter. Weight records shall be kept on file for 2 years.

Resident D's weight was not recorded for October 2021. Resident K's weight was not recorded October 2020 or July, September, and October 2021.

During the onsite inspection, I reviewed Resident D's medication administration records (MARs) and noted the following:

- Resident D's July 2021 MAR was not initialed for the 5:00pm dose of Urea Cream on 07/09/21 or 07/31/21.
- Resident D's July 2021 MAR was not initialed for 5:00pm medications on 07/11/21.
- Resident D's August 2021 MAR was not initialed for evening medications on 08/19/21 or 08/27/21.
- Resident D's August 2021 MAR was not initialed for AM medications on 08/30/21.
- Resident D's August 2021 MAR was not initialed for 5:00pm medications on 08/24/21 or 08/29/21.
- Resident D's December 2021 MAR was not initialed for 7:00am medications on the day of the onsite inspection, 12/14/21.

R 400.14313	Resident nutrition.
	(4) Menus of regular diets shall be written at least 1 week in advance and posted. Any change or substitution shall be noted and considered as part of the original menu.

During the onsite inspection, I observed that staff had not consistently written in substitutions on the menus.

R 400.14403	Maintenance of premises.
	(1) A home shall be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.

During the onsite inspection, I observed that the locks on the doors to bedroom #2 and bedroom #3 were broken.

#### IV. RECOMMENDATION

An acceptable corrective action plan has been received. Renewal of the license is recommended.
