#### IV. Description of Findings and Conclusions

On 05/20/2022, I received a written request from Licensee Designee, Patricia Thomas to increase the capacity of the Weyer Afc home from five to six residents. The home is currently licensed for five residents. I completed an onsite to measure the bedrooms.

The living rooms and dining area offer a total of 650 square feet which meets the required 35 square feet per person for six residents.

The four bedrooms in the home are sized as follows:

Total capacity: 6

All four bedrooms have adequate space, bedding and storage. The home has adequate space to care for six residents.
