### **III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

This facility was found to be in non-compliance with the following rules:

R 400.15401	Environmental health.
	(2) Hot and cold running water that is under pressure shall be provided. A licensee shall maintain the hot water temperature for a resident's use at a range of 105 degrees Fahrenheit to 120 degrees Fahrenheit at the faucet.

During the onsite inspection completed on 05/10/2022, the water temperature in Bedroom # 1 was 100.6° Fahrenheit. Bedroom # 3 was 124.3° Fahrenheit. Bedroom # 8 was 123.6° Fahrenheit. Bedroom # 9 was 123.3° Fahrenheit. Bedroom # 10 was 122.7° Fahrenheit. Bedroom # 12 was 120.6° Fahrenheit and Bedroom # 15 was 120.6° Fahrenheit.

R 400.15403	Maintenance of premises.
	(1) A home shall be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.

On 4/22/2022, Oakland County Bureau of Fire Safety gave a B rating for the following deficiencies. #1 delayed egress locks complying with 7.2.1.6.1 shall be permitted for exit doors only. #2 For existing hazarded areas shall be protected in accordance with section 33.3.3.2.2.

R 400.15408	Bedrooms generally.
	(7) Bedrooms shall have at least 1 easily openable window.

During the onsite inspection completed on 05/10/2022, Bedroom # 2, Bedroom # 7, and Bedroom # 13 had an air conditioning unit attached to the window obstructing the window from easily opening.

## IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
