## II. Purpose of Addendum

The purpose of this addendum is to document the facility's programming change to discontinue their secured memory care program. The doors to the secured memory care unit will be removed to open the facility to provide general assisted living services.

## III. Methodology

On 9/13/22, The facility submitted a request to open the secured memory care unit and discontinue its secured memory care program. The facility identified that the demographics of the current locked area does not allow for optimal supervision of residents with the two long halls in the secured unit that are angled. Removing the doors to open the secured memory care unit will allow staff to float throughout the facility and continue to provide care to residents with a general assisted living program.

The facility will work with families and/or guardians to secure placement for its residents who require the supervision and services of a secured setting. The facility will pay all moving costs associated with moving residents to an alternate secured memory care placement.

On 9/19/22, the facility received approval from fire marshal Phil Scheer to remove the doors to the secure memory care unit.

On 10/6/22, I reviewed and approved the facility's revised program statement and discharge policy that addressed the removal of the secured memory care unit.

## IV. Description of Findings and Conclusions

The facility provided a request to remove its secured memory care unit and programming. The facility is working with the families and/or guardians of residents who require continued memory care programming to find an alternate placement. With the removal of the secured memory care unit, the facility will be able to fully serve residents who require general assisted living services.

## V. Recommendation

I recommend approval of the removal of the facility's secured memory care unit and programming.
