II. Purpose of Addendum

Mr. Bos requested to decrease the capacity of the home for the aged (HFA) by eliminating 60 resident beds on the second floor of the facility with rooms numbered 301-325 and 402-432. Mr. Bos requested to change the number of assisted living beds to 155 beds total for the facility.

III. Methodology

On 11/2/2022, Mr. Bos applied to decrease from 215 licensed beds to 155 licensed beds. On 11/14/2022, I completed an on-site inspection. The Health Facilities Engineering Section room sheets were reviewed for the rooms identified to have a decrease in beds.

IV. Description of Findings and Conclusions

I reviewed HFES room sheets and determined rooms numbered 304, 306, 308, 310, 312, 314, 316-322, 324-325, 406, 408, 410, 412, 414, 416-422, 424-428 are licensed one bed with 204 sq ft, built in closets, and connected bathrooms. Rooms numbered 301-303, 305, 307, 309, 311, 313, 315, 401-405, 407, 409, 411, 413 and 415 are two licensed beds with 260 sq ft, built in closets, connected bathrooms. Day/dining space is adequate to support this decrease of 60 licensed beds.

V. Recommendation

It is recommended the license capacity decrease to reflect 155 licensed beds.
