II. Purpose of Addendum

Modification request has been received to increase the capacity of the Safe Haven Assisted Living of Mason facility from 16 beds to 20 beds.

III. Methodology

Renewal inspection completed on 10/12/2022. There has been an additional bathroom added to the facility, and approved by Bureau of Fire Safety on 10/18/22, bringing the total number of full bathrooms to three.

IV. Description of Findings and Conclusions

The facility has adequate living space and bedrooms to accommodate 20 residents. Original LSR noted licensure for 16 beds due to the facility needing to have an additional bathroom. The additional bathroom has since been added and approved by BFS. There are now three full bathrooms in the facility. Two of these bathrooms are fully handicap accessible.

V. Recommendation

Recommend increasing facility capacity from 16 to 20 beds.
