### **III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

This facility was determined to be in substantial compliance with rules and requirements.

This facility was found to be in non-compliance with the following rules:

R 400.15208 Direct care staff and employee records.

- (1) A licensee shall maintain a record for each employee. The record shall contain all of the following employee information:
- (e) Verification of experience, education, and training.

At the time of inspection, 1 of 3 employee records reviewed did not contain verification of education.

R 400.15208 Direct care staff and employee records.

- (1) A licensee shall maintain a record for each employee. The record shall contain all of the following employee information:
- (f) Verification of reference checks.

At the time if inspection, 1 of 3 employee records reviewed did not contain verification of education.

R 400.15318 Emergency preparedness; evacuation plan; emergency transportation.

(5) A licensee shall practice emergency and evacuation procedures during daytime, evening, and sleeping hours at least once per quarter. A record of the practices shall be maintained and be available for department review.

At the time of inspection, I observed the following;

- No evening drill conducted during the 2<sup>nd</sup> quarter of 2021.
- No sleep drill conducted during the 3<sup>rd</sup> quarter of 2021.
- No day, evening or sleep drill during the 4<sup>th</sup> quarter of 2021.
- No evening or sleep drill conducted during 1<sup>st</sup> quarter of 2022.
- No evening drill conducted during the 2<sup>nd</sup> guarter of 2022.
- No day or evening drill conducted during the 3<sup>rd</sup> quarter of 2022.
- No day or evening drill conducted during the 4<sup>th</sup> quarter of 2022.

## IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
