## **IV. Description of Findings and Conclusions**

Based on the information received and documents reviewed, the licensee designee, Goodwin Ilonze is qualified to provide services to the aged population. Mr. Ilonze has been an Adult Foster Care provide for over five years. He has experience working with elderly patients as a Nursing Assistant and he has worked in long term care facilities as a Licensed Professional Nurse (LPN) for 12 years. Mr. Ilonze will conduct a thorough assessment prior to accepting residents into the home to ensure that they are compatible with the other residents at Annextra Healthassist Associates. Mr. Ilonze will not accept residents who are non-ambulatory as the Annextra Healthassist Associates home is not wheelchair accessible.

**V. Recommendation**

I recommend that aged be added to the program type of Annextra Healthassist Associates.




