ALLEGATION:

Staff did not provide Resident A medical care.

INVESTIGATION:

On 3/21/2023, APS and ORR referrals were made.

On 3/21/2023, I interviewed staffs Jessica Huffman and Matthew Hescheles. They both stated that after Resident B bit Resident A, it was the responsibility of the shift leader, Dylan Vickers, to contact the manager on call and the nurse on call.

On 3/21/2023, I interviewed staff Dylan Vickers. He admitted that he was responsible for contacting the manager on call and the nurse on call after Resident A was bitten/injured. He admitted that he did not follow up with the appropriate staff and stated he was suspended from work.

On 3/22/2023, I contacted Resident A's guardian. She stated that when she visited Resident A, she discovered the bite marks and that no medical care had been provided, outside of a bandage over the bitemark. She also stated that she was dissatisfied with his placement and has requested an alternate placement.

On 3/22/2023, I contacted Resident B's guardian. She stated she was satisfied with his placement at Eisenhower Center and knew of no alternate placements.

On 3/27/2023, Residents A and B were observed, but not interviewed since they are both non-verbal.

On 3/27/2023, I conducted an exit conference with the licensee designee, Dan Bogosian.

APPLICABLE RULE	
R 400.15310	Resident health care.
	(4) In case of an accident or sudden adverse change in a resident's physical condition or adjustment, a group home shall obtain needed care immediately.
ANALYSIS:	After Resident B hit Resident A's, the responsible staff, Dylan Vickers admitted that he did not notify the manger on call or the nurse on call. Therefore, the Eisenhower Center staff did not obtain needed care immediately.
CONCLUSION:	VIOLATION ESTABLISHED

ALLEGATION:

Resident B bit Resident A.

INVESTIGATION:

(This is the only additional information from the previous section that is specific to Resident A being bitten by Resident B).

On 3/21/2023, I interviewed staff Jessica Huffman regarding her 3/18/2023 incident report describing Resident B physically attacking and biting Resident A's hand. She stated that Resident A was walking out of his bedroom when Resident B became agitated and lunged at Resident A biting his shoulder and his hand. She stated that Resident B's 1:1 staff were within eyesight of the residents, but Resident B moved so fast and unexpected that they could not anticipate his response. She stated that she and 2 other staff separated Resident A and B immediately.

APPLICABLE RULE	
R 400.15305	Resident protection.
	(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.
ANALYSIS:	Since the staff were unable to prevent Resident B from attacking and biting Resident A, then Resident A's protection and safety was not attended to at all times.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION


Contingent upon receipt of an acceptable plan of correction; I recommend no change in the status of the license.
