## ALLEGATION:

On 4/17/23, staff Deondre Daniels threatened Resident A with "I'll lose my job today. I'll fuck you up! I'll beat your ass!" Residents B and C heard the threat.

## **INVESTIGATION:**

On 4/18/23, a phone call was made to recipient rights investigator, Kim Nguyen-Forbes, who confirmed that she is investigating the same allegations. She stated that she had already interviewed Resident A, Resident B, and Resident C. She reported that all three residents confirmed that staff Deondre Daniels verbally threatened and cussed at Resident A.

On 4/25/23, an on-site inspection was conducted, and Resident A, Resident B and Resident C were interviewed. Resident A stated that staff Deondre Daniels was mad at him for throwing the chili away that he made. He stated that he hates Mr. Daniels cooking. Resident A reported that Mr. Daniels yelled at him saying "I will lose my job" and "I will fuck your ass up." Resident A stated that Resident B and Resident C witnessed Mr. Daniels saying these things to him.

Resident B and Resident C were interviewed together at the dining room table and they both confirmed that they witnessed the confrontation between Resident A and Mr. Daniels. They both stated that they heard Mr. Daniels threaten and cuss at Resident A because he was mad that Resident A threw the chili away that he made. Resident B stated that he could not remember the exact statements that Mr. Daniels said but confirmed that Mr. Daniel used the word "fuck." A few minutes later, an attempt was made to gain more detailed information from Resident C privately, but he refused to talk further about the incident.

On 4/25/23, home manager, Phillip Parrish, stated that he worked with Mr. Daniels the day of the alleged threats and cussing. Mr. Parrish stated that he told Mr. Daniels that Resident A threw the chili away that he had made. He reported that Mr. Daniels was "steamed" and made a comment about that if he did not work here that he would beat Resident A's ass. Mr. Parrish stated that was a private conversation between he and Mr. Daniels and that he was not present for the confrontation between Mr. Daniels and Resident A and did not hear Mr. Daniels threaten or cuss at Resident A.

On 4/25/23, a phone interview was conducted with staff person, Deondre Daniels, who stated that he was not in the home when Resident A dumped the chili. Mr. Daniels claims that when he returned to the home, he did not say anything to Resident A and that it was Resident A that kept getting into his face and trying to instigate things. Mr. Daniels stated that he just walked away from Resident A and denied that he threatened to beat Resident A's ass or that he cussed at Resident A.

On 4/25/23, a phone call was made to administrator, Regina Wheaton. She stated that she went to this home later that day after the confrontation between Resident A and Mr. Daniels. She stated that Resident A told her that Mr. Daniels cussed at him and threatened to "beat his ass." Ms. Wheaton reported that she spoke to Resident B and Resident C. She stated that Resident B told her that he heard Mr. Daniels cuss and threaten Resident A. She stated that Resident C told her that Mr. Daniels was made at Resident A, but that he did not hear any threats or cussing.

On 5/24/23, an ORR summary report was received from Recipient Rights Investigator, Kim Nguyen-Forbes. The report stated that she found evidence that Mr. Daniels threatened and cussed at Resident A and in front of Resident B and Resident C. It stated that she was able to substantiate a violation of Resident A's rights to be free from Abuse Class III threatening communication and Resident B and Resident C's right to be treated with dignity and respect.

Resident B and<br>Resident C confirmed that they heard Mr. Daniels cuss at and<br>threaten Resident A. There was sufficient evidence found to<br>support the allegations that Resident A was verbally abused by<br>Mr. Daniels and that Mr. Daniels made verbal threats to harm<br>Resident A. |
