III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

R 325.1953 Menus.

(1) A home shall prepare and post the menu for regular and therapeutic or special diets for the current week. Changes shall be written on the planned menu to show the menu as actually served.

Interview with Employee #1 revealed there were three residents who were prescribed mechanical soft diets. Employee #1 stated the facility lacked preparing and posting a mechanical soft diet menu.
