II. Purpose of Addendum

To increase the licensed bed capacity of the facility from 45 to 46.

III. Methodology

On 3/30/2022, Carrie Good submitted a request to increase the licensed bed capacity of the facility from 45 to 50 beds.

Health Facilities Engineering Section (HFES) room sheets for the home for the aged were reviewed.

On, 6/22/2023, Carrie Good submitted an HFES permit for construction letter and form to the Department.

On 6/27/2023, HFES Riyadh Almuktar approved resident room 210 to be licensed for two beds.

IV. Description of Findings and Conclusions

On 3/30/2022, the Department received a letter from authorized representative and administrator Carrie Good which requested to increase the licensed bed capacity of the facility from 45 to 50 beds. The letter read requested the following apartments 201, 210, 213B, 218, and 219 each increase to two licensed beds.

I reviewed the facility's room sheets dated 2/15/1996 which read apartment 201 was 240 square feet, licensed for 0 beds and designated for a "boarder." The room sheets read apartment 201 and 213 ½ were licensed for one bed. The room sheets read apartments 218 and 219 were licensed for a "boarder."

On 4/1/2022, email correspondence with Carrie Good read apartment 213B was supposed to be 213 ½.

On 11/23/2022, the Department emailed the completed BCAL-1605 form with instructions on how to proceed with the request to increase the licensed bed capacity to Bureau of Fire Services (BFS) and Health Facilities Engineering Section (HFES).

On 6/22/2023, a Permit for Construction form and letter dated 3/20/2023 and completed by HFES staff Riyadh Almuktar were forwarded to the Department and reviewed. The letter read in part a site visit was conducted on 3/16/2023, and it was determined only resident room 210 could take/add one additional bed and be converted from private to semi-private with a minimum size wardrobe of five square foot. The letter read all other requested rooms 201, 213 ½, 218 and 219 could not accommodate an additional bed. The form read in part HFES Project #20230012 involved the increase of the existing total bed capacity of the Home for the Aged from the existing 45 beds to the new 46 bed (increase by 1 bed) without any construction or modifications.

On 6/27/2023, Carrie Good forwarded email correspondence from HFES Riyadh Almutkar which read resident room 210 was approved for double occupancy.

V. Recommendation

I recommend apartment 210 be licensed for two beds and to increase the facility's licensed bed capacity from 45 to 46.
