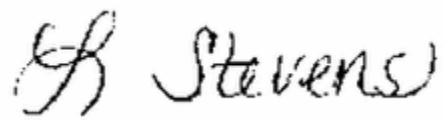
Attached is the Renewal Licensing Study Report for the facility referenced above. The violations cited in the report require the submission of a written corrective action plan. The corrective action plan is due 15 days from the date of this letter and must include the following:

- How compliance with each rule will be achieved.
- Who is directly responsible for implementing the corrective action for each violation.
- Specific dates for each violation as to when the correction will be completed or implemented.
- How continuing compliance will be maintained once compliance is achieved.
- The signature of the licensee or licensee designee or home for the aged authorized representative and a date.

Upon receipt of an acceptable corrective plan, a six-month provisional license is recommended. If you do not contest the issuance of a provisional license, you must indicate so in writing; this may be included in your corrective action plan or in a separate document. If you contest the issuance of a provisional license, you must notify this office in writing and an administrative hearing will be scheduled. Even if you contest the issuance of a provisional license, you must still submit an acceptable corrective action plan within 15 days.

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

R 400.15208 Direct care staff and employee records.

(1) A licensee shall maintain a record for each employee. The record shall contain all of the following employee information:

(f) Verification of reference checks.

At the time of inspection verification of reference checks was not available for review.

R 400.15315 Handling of resident funds and valuables.

(12) Charges against the resident's account shall not exceed the agreed price for the services rendered and goods furnished or made available by the home to the resident.

The facility accepts residents with total Supplemental Social Security Income (SSI). However, the resident was assessed fees higher than allotted from his SSI payments.

R 400.15315 Handling of resident funds and valuables.

(2) The care of any resident funds and valuables that have been accepted by a licensee for safekeeping shall be treated by the licensee as a trust obligation.

During the inspection period I reviewed residents banking account statements. Upon review of statements, it appears monies were taken from residents' accounts that exceeded their cost of care and allowance. When I inquired on the difference, I was informed the accounts were hacked electronically. I asked for banking documentation for said time frame. To date, I have not received that information.

Based on information reviewed Resident A's account was debited an additional \$259.50 September 2022, \$940.50 in February 2023 and \$1,059.50 in March 2023. Per these calculations, Resident A is owed \$2,259.50.

Resident B was debited an additional \$960.50 June 2022, \$960.50 April 2023, \$1,579 March 2023. Per these calculations Resident B is owed \$3,500.00.

R 400.15403 Maintenance of premises.

(1) A home shall be constructed, arranged, and maintained to provide adequately for the health, safety, and well-being of occupants.

At the time of inspection, the back of toilet was broken, and the shower curtain needed rods.

R 400.15403 Maintenance of premises.

(13) A yard area shall be kept reasonably free from all hazards, nuisances, refuse, and litter.

At the time of inspection, vehicle car seats were out of the vehicle and in the yard. The grass needed maintenance and the fence needed repair/maintenance.

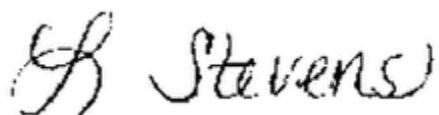
R 400.15403 Maintenance of premises.

(2) Home furnishings and housekeeping standards shall present a comfortable, clean, and orderly appearance.

At the time of inspection, the living room furniture was extremely worn and in need of replacement.

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, issuance of a provisional license is recommended.
