

**ALLEGATION: Resident A is being abused at the current AFC home.**

**INVESTIGATION:** On 07/05/2023, I completed an unannounced onsite inspection. I interviewed Resident A and Heidi Justice, licensee designee. Resident A stated she is not being abused in the home. Resident A stated she is abused by her guardian. She indicated she does not receive her monies/allowance. She indicated her guardian is responsible for giving her monies. Resident A stated she is new to this facility. She stated she has lived in the home for one month.

During my interview with Mrs. Justice, she stated Resident A has been in contact with her guardian regarding her monies. She stated she has no control over her finances.

<b>APPLICABLE RULE</b>	
<b>R 400.14305</b>	<b>Resident protection.</b>
	<b>(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.</b>
<b>ANALYSIS:</b>	There is no evidence Resident A is not treated with dignity and respect. Resident A stated she is not being abused in the facility. She stated her concern is with her guardian.
<b>CONCLUSION:</b>	<b>VIOLATION NOT ESTABLISHED</b>

**ADDITIONAL FINDINGS:**


**INVESTIGATION:** During my onsite inspection I observed Resident A to be utilizing a walker. According to Resident A, on 6/15/2023, slipped on mud and fell at the facility. Resident A stated she utilizes a wheelchair and walker. I reviewed Resident A's health care appraisal dated 06/28/2023. Per her appraisal completed by Dr. Bryant, Resident A utilizes a wheelchair and walker due to having "unsteady gait due to lower extremity weakness."

I completed a face-to-face exit conference with Mrs. Justice. She was informed this complaint will be substantiated due to her having a resident that requires a wheelchair/walker and not having approved ramps. Mrs. Justice stated she has already submitted paperwork for an emergency discharge for Resident A and is awaiting placement.

<b>APPLICABLE RULE</b>	
<b>R 400.14509</b>	<b>Means of egress; wheelchairs.</b>
	<b>(1) Small group homes that accommodate residents who regularly require wheelchairs shall be equipped with ramps that are located at 2 approved means of egress from the first floor.</b>
<b>ANALYSIS:</b>	Resident A has been prescribed a wheelchair and walker for ambulation. The facility is not equipped with wheelchair ramps to accommodate Resident A.
<b>CONCLUSION:</b>	<b>VIOLATION ESTABLISHED</b>

#### IV. RECOMMENDATION

Contingent upon submission of an acceptable corrective action plan, I recommend the status of the license remain the same.
