Ms. Nowak also completed a program statement which addresses all areas required in MCL 400.726b. Ms. Nowak also completed additional trainings including 10 Warning Signs of Alzheimer's, Understanding Alzheimer's and Dementia, and Caregiving Skills – Dementia Care which will assist her in working with residents diagnosed with Alzheimer's. **LICENSEE DOES NOT HAVE ONE YEAR OF EXPERIENCE WITH ALZHEIMER'S DISEASE. CANNOT SIGN AT THIS TIME.**

I recommend the modification request to allow residents who are diagnosed with Alzheimer's and Dementia to reside at Tranquility House AFC, LLC be approved.
