II. Purpose of Addendum

The purpose of this addendum is to document an increase in capacity, to 18 residents, and to add "wheelchair accessible" to the license.

III. Methodology

September 20, 2023 – On-site inspection completed

IV. Description of Findings and Conclusions

A previously used office has been converted into a double occupancy resident bedroom. This room measures 12 feet by 18 ft or 216 square feet of floorspace. It has a full on-suite bathroom which can be used by the residents of this bedroom.

A previously licensed single occupancy resident bedroom has been modified and will now serve as a double occupancy resident bedroom. This room measures 13 feet 10 inches by 9 feet 5 inches, or 130 square feet of floorspace.

The facility has 727 square feet of "common space" for resident use. This constitutes approximately 40 square feet of common space per resident, exceeding the minimum of 35 square feet per resident.

The home has two wheelchair ramps on opposite sides of the facility.

V. Recommendation

I recommend the capacity be increased to a maximum of 18 residents and that "wheelchair accessible" be added to the license.
