On 08/24/2023, the license requested an inspection to change the capacity of a two resident bedroom to a one resident bedroom and designate an additional room as a single resident bedroom.

On 06/05/2023, I completed an inspection on-site and verified this new resident bedroom met all licensing requirements for resident bedrooms.

I approve the addition of one resident bedroom with no change in licensed capacity for this facility, which remains at a capacity of six (6).
