II. Purpose of Addendum

The purpose of this addendum is to indicate that L & W Adult Foster Care Home is wheelchair accessible.

III. Methodology

05/09/23 - During a renewal inspection I observed that the L & W Adult Foster Care Home was not equipped with ramps at two approved means of egress from the first floor. The home had one ramp located off the front door of the home.

10/02/23 - I received a Corrective Action Plan that provided photo evidence that a second ramp was installed.

11/07/23 - I completed an onsite inspection and verified that the home installed a second wheelchair accessible ramp.

IV. Description of Findings and Conclusions

Based on the information reviewed and my onsite inspection, L & W Adult Foster Care Home is wheelchair accessible. The home is equipped with two ramps at two approved means of egress. There is one ramp at the front door and a second ramp located off the laundry room that exits into the garage. L & W Adult Foster Care Home is a two-story home. Residents who have impaired mobility shall not sleep in or be assigned a bedroom that is located above the street floor of the home. The home has resident bedrooms that are located upstairs. These bedrooms are not wheelchair accessible.

V. Recommendation

I recommend that L & W Adult Foster Care Home be wheelchair accessible.


