ALLEGATION:

Resident A was observed to be in the bathroom with staff Rian Jeans. Staff Leona Crosby found Resident A with a towel wrapped around his neck and a red bruise under his left eye.

INVESTIGATION:

On 11/15/2024, I received the allegations from recipient rights advocate Rishon Kimble.

On 11/28/2024, I conducted a telephone interview with recipient rights advocate Rishon Kimble. Ms. Kimble confirmed she is also investigating the allegations and will likely substantiate them. Ms. Kimble interviewed home manager Phelon Hodge. Per Mr. Hodge, staff Rian Jeans stated he put the towel around Resident A's neck because he was screaming. He denied trying to choke Resident A. Ms. Kimble interviewed staff

Leaona Crosby. Ms. Crosby stated she heard Resident A screaming. When she entered the bathroom where Mr. Jeans and Resident A were at, she observed a towel around Resident A's neck and a red bruise on Resident A's eye. Mr. Jeans informed Ms. Crosby that Resident A hit his eye on the shower chair. Ms. Crosby told Ms. Kimble she did not think it was likely that Resident A hit his eye on the chair. Ms. Kimble interviewed Mr. Jeans. Mr. Jeans stated he tried to put the towel over Resident A's face because he was screaming. He stated Resident A puts the cover over his face at night and it calms him down. Mr. Jeans thought putting the towel over Resident A's face would calm him down as well. Ms. Kimble stated Ms. Jeans was placed on leave pending the investigation.

On 11/28/2023, I forwarded the allegations to adult protective services (APS).

On 12/01/2023, I conducted an unannounced onsite investigation. I interviewed home manager Phelon Hodge. Mr. Hodge stated when he arrived at the facility, Mr. Jeans informed him while in the bathroom, Resident A was trying to stand up. In the process, he lost his balance and hit his face. Resident A sustained a small cut on his eye. When Mr. Jeans left the facility, Ms. Crosby informed Mr. Hodge that she heard Resident A screaming. When she entered the bathroom, she observed Mr. Jeans exiting the bathroom. Mr. Jeans informed her he needed to smoke a cigarette. Ms. Crosby observed Resident A with a towel wrapped around his face. Ms. Crosby removed the towel and got Resident A dressed. Mr. Hodge stated Mr. Jeans has worked in the facility for at least five years. Mr. Jeans is currently suspended pending the investigation.

While at the facility, I observed Resident A. I was unable to interview him due to his limited cognitive abilities.

On 12/05/2023, I conducted a telephone interview with staff Leaona Crosby. Ms. Crosby confirmed she heard Resident A screaming. Mr. Jeans seemed like he was having a bad day. While Ms. Crosby was walking in the bathroom to check on Resident A, she observed Mr. Jeans walking out of the bathroom. Mr. Jeans went outside to smoke a cigarette. Ms. Crosby observed Resident A in the bathroom with a towel wrapped around his mouth and neck. Ms. Crosby stated she removed the towel, got Resident A dressed, and fed him. Ms. Crosby confirmed Resident A had a mark on his eye. Mr. Jeans informed her Resident A sustained the mark from falling and hitting the shower chair. Ms. Crosby stated that was not possible as Resident A was unable to stand up that day. Ms. Crosby did not know how Resident A sustained the mark on his eye.

On 12/14/2023, I attempted to conduct a telephone interview with staff Rian Jeans with no success. Mr. Jeans stated I could talk to his lawyer because he had already talked enough about this incident. He stated he was not talking about it anymore. In addition, Mr. Jeans said, "fuck you" and then hung up the phone.

On 01/03/2024, I conducted a telephone interview with Oakland County Sheriff's Office detective Janes. She stated the investigation has been forwarded to the Prosecutor's Office due to abuse and neglect and a warrant may be issued. Detective Janes did not know what the warrant will be issued for.

On 01/03/2024, I attempted to conduct an exit conference with licensee designee Roger Covill. I left a message.

ANALYSIS:	Ms. Crosby heard Resident A screaming in the bathroom. She observed Resident A with a towel wrapped around his mouth and neck. Ms. Crosby stated she removed the towel, got Resident A dressed, and feed him. Ms. Crosby confirmed Resident A had a mark on his eye. Mr. Jeans informed her Resident A sustained the mark from falling and hitting the shower chair. Ms. Crosby stated that was not possible as Resident A was unable to stand up that day. Ms. Crosby did not know how Resident A sustained the mark on his eye. Mr. Jeans did not cooperate with the investigation. I was unable to interview Resident A due to his limited cognitive abilities. Detective Janes stated the investigation has been forwarded to the Prosecutor's Office due to abuse and neglect and a warrant may be issued.
