III. METHODOLOGY

ALLEGATION:

Staff were disrespectful to Resident A.

INVESTIGATION:

On 1/17/24, I was assigned a complaint from the LARA online complaint system.

On 1/18/24, I was contacted by rights officer Sarah Watson from the Central Michigan Community Mental Health. Ms. Watson stated she had video conference interviews scheduled for 1/19/24 with direct care staff and Resident A.

On 1/19/24, rights officer Sarah Watson and I did a joint video interview with direct care staff (DCS) who were at the home.

We first interviewed DCS Roxann Arman-Brooks. Ms. Arman-Brooks stated DCS Tonya Sharp and Kelly Evans have made inappropriate comments to Resident A about holding his penis and touching himself. She stated she has heard them make these types of comments on at least two occasions. She stated she heard them say these things between Thanksgiving and Christmas. Ms. Arman-Brooks stated that Resident A would come out of his room and socialize a lot more before they started making these types of comments to him. She stated now he just likes to stay in his room and be by himself.

We then interviewed DCS Richard Beegan. Mr. Beegan stated that Resident A has reported to him that other staff told him he was in his room "jacking off." Mr. Beegan stated he has not witnessed other staff say these things to residents.

We then interviewed DCS Tonya Sharp. Ms. Sharp stated Resident A typically spends time in his room. She stated they used to joke around with him a lot but not anymore. She denied making any sexual comments or jokes to him.

We then interviewed DCS Kelly Evans. Ms. Evans denied making any disrespectful comments to Resident A.

We then interviewed Resident A. Resident A stated DCS Tonya Sharp and Kelly Evans have both made comments to him telling him to, "get off my phone, get my dick out of my hand and quit jerking off." He stated these comments were made around Christmas and since that time he has not wanted to come out of his room. He stated he feels like he was disrespected and that they are going to continue to make disrespectful comments to him.

We then interviewed the licensee designee Roxanne Goldammer. Ms. Goldammer stated she was not previously aware of the statements allegedly made to Resident A by staff. She stated statements like that were not acceptable nor are they consistent with the training staff receive on how to talk with residents. Ms. Goldammer stated both staff would be suspended pending the investigation.

On 2/5/24, I conducted an unannounced onsite inspection at the facility. I interviewed manager Sarah Patterson at the home. Ms. Patterson stated that both Ms. Sharp and Ms. Evans were suspended on 1/19/24. She stated that Ms. Sharp quit immediately, and Ms. Evans remains on suspension pending the investigation. Ms. Patterson stated Resident A has been more social and spending more time outside of his bedroom since they were both suspended.

On 2/5/24, I interviewed Resident A at the home. Resident A stated things are going well. He stated there is less tension in the home and he is more social. He stated all the other staff are treating him with respect.

ANALYSIS:	 The complaint alleges staff were disrespectful to Resident A. While interviews with Ms. Sharp and Ms. Evans resulted in both denied making disrespectful statements towards Resident A, interviews with Ms. Armon-Brooks, Mr. Beagen, and Resident A revealed evidence that the alleged disrespect had taken place. The licensee designee Roxanne Goldammer stated the actions of Ms. Sharp and Ms. Evans were not consistent with the training they receive. 	
CONCLUSION:	VIOLATION ESTABLISHED	

On 2/6/2024, I conducted an exit conference with the licensee designee Roxanne Goldammer. Ms. Goldammer concurred with the findings of the investigation. She stated Ms. Evans and Ms. Sharp have both resigned. She stated she will submit a corrective action plan for approval.

IV. RECOMMENDATION

Upon receipt of an acceptable corrective action plan, I recommend no change in the status of the license.
