ALLEGATION:

A staff member is stealing Resident A's medications.

INVESTIGATION:

On 2/12/24, I conducted an unannounced onsite inspection at the home. Direct care staff (DCS) Netty Deman stated she was not aware of any missing medications for Resident A. She stated they conduct medication counts for all medications three times a day. Ms. Deman showed me all of Resident A's medications which I cross-referenced with his medication administration records for February 2024. I also reviewed the medication count sheets for February 2024 and all Resident A's medications were accounted for.

I then interviewed Resident A. Resident A stated he always receives all his medications. He stated he is not aware of any medications stolen from him.

On 2/14/24, I conducted another onsite inspection at the home. The home manager, Joy Miller stated she has reviewed all the resident medications and has not discovered any missing medications. She stated the home does medication counts at 9 a.m., 12 p.m., and Midnight every day. I again reviewed all Resident A's medications, medication administration records, and medication count sheets which showed all Resident A's medications were accounted for.

I then interviewed direct care staff (DCS) Jack Frost. Mr. Frost denied stealing any medications. He stated they do medication counts for all medication three times daily.

R 400.14312	Resident medications.
	(1) Prescription medication, including dietary supplements, or individual special medical procedures shall be given, taken, or applied only as prescribed by a licensed physician or dentist. Prescription medication shall be kept in the original pharmacy-supplied container, which shall be labeled for the specified resident in accordance with the requirements of Act No. 368 of the Public Acts of 1978, as amended, being S333.1101 et seq. of the Michigan Compiled Laws, kept with the equipment to administer it in a locked cabinet or drawer, and refrigerated if required.
ANALYSIS:	The complaint alleges staff Jack Frost is stealing Resident A's medications.
	Interviews with Resident A, Ms. Deman, Mr. Frost and Ms. Miller revealed no concerns regarding any missing medications. Resident A's medications, medication administration records, and medication count sheets for February 2024 were all reviewed and revealed no missing medications.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 4/2/24 I conducted an exit conference with licensee designee Jonathon Harland. Mr. Harland concurred with the findings of the investigation.

IV. RECOMMENDATION

I recommend no change in the status of the license.
