On 04/01/2024, I received a phone call from Ms. Lark. Ms. Lark and I discussed increasing the capacity of residents in bedroom number one. Ms. Lark had inquired about this at the original on-site inspection conducted on January 24, 2024. I informed Ms. Lark that I would email her a *Modification of the Terms of the License* form to complete. I emailed the document to Ms. Lark.

04/01/2024 I reviewed the original license study report dated January 26, 2024. I observed that bedroom number one measured 130 square feet.

On 04/10/2024, I received a *Modification of the License* terms to increase the capacity from one resident to two residents.

On 04/11/2024, I received a video of the bedroom number one. I observed two beds and a large dresser.

## IV. Description of Findings and Conclusions

Resident bedrooms were measured during the on-site inspection and have the following dimensions:

Bedroom #	Room Dimensions	Total Square Footage	Total Resident Beds
1	11 x 11.10	130	2

There is sufficient space in bedroom number one to accommodate two residents. The bedroom has two twin-sized beds and a large dresser.

## V. Recommendation

I recommend increasing the capacity from one resident to two residents.
