#### ALLEGATION:

# Employees are selling dogs on the premises and too many visitors come to the home.

#### INVESTIGATION:

On 7/26/22 I interviewed employee Bobbie Cilley at the home. Ms. Cilley stated that she is a live-in employee at the home. She stated that her daughter-in-law Brittany Rogers has sold puppies. Ms. Cilley acknowledged that when she is not on shift, she does have visitors come to her area of the home, but that they do not congregate for any length of time with the residents. She stated that the presence of the dogs has in no way affected the staff's ability to respond to residents' needs. She stated that her sister sometimes visits but that her children play outside.

I interviewed Resident A. He stated that he likes it at the home. He was unable to provide any other information.

I interviewed Resident B. She did not provide any relevant information.

On 7/28/22, I interviewed the complainant who provided further information, that the assigned employee on shift was performing her duties while visitors and dogs were all there. The complainant recalled that the employee, Brittany Rogers, was in fact attending to a resident's wound at the time.

On 7/28/22, I interviewed licensee Vicki Cates by telephone. She advised that she has addressed the issue of numerous visitors in the home and asked that arrangements be made to sell the puppies somewhere else.

On 9/2/22, I received information from the complainant that there were no further issues with dogs at the home.

APPLICABLE RULE	
R 400.14305	Resident protection.
	(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.
ANALYSIS:	During my onsite visit, there was no evidence of dogs, or dogs being sold out of the home. Employees acknowledged that from time to time dogs have been sold, but the transactions are confined to the live-in employee's section of the home and do not interfere with the duties of taking care of the residents; a collateral source confirmed this idea. The licensee has addressed the issue of visitors and dog sales and directed the employees to limit visitors and make arrangements for the dog sales to take place elsewhere.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 9/13/22, I conducted an exit interview with licensee designee Vicki Cates. I shared the findings of my investigation, and she was in agreement.

## IV. RECOMMENDATION

I recommend no change to the status of the license.
