ALLEGATION:

Employees threatened to throw away a resident's belongings if the rooms were not cleaned.

INVESTIGATION:

On 1/25/24, I interviewed employee Barbara Proffitt in the home. Ms. Proffitt denied threatening to throw away a resident's belongings if the rooms were not cleaned. Ms. Proffitt stated that the employees are responsible for housekeeping.

I interviewed Resident A in the home. Resident A denied being threatened by employees about cleaning the room.

I interviewed Resident B in the home. Resident B denied hearing any employees threaten to throw away residents' belongings.

I observed the home in general to be clean and well maintained during the onsite inspection.

On 2/6/24, I interviewed employee Amanda Cilley in the home. Ms. Cilley denied threatening any residents in the home over cleaning standards. Ms. Cilley stated that Resident A had too many things in the room and advised him that she needed to help him organize the room since his belongings reduced the amount of space his room mate had for his belongings. She stated that she advised Resident A that she would have to discard any items of garbage in the room.

APPLICABLE RULE	
R 400.14305	Resident protection.
	(3) A resident shall be treated with dignity and his or her personal needs, including protection and safety, shall be attended to at all times in accordance with the provisions of the act.
ANALYSIS:	Residents and employees denied that an employee threatened to throw away their belongings. Employees and residents advised that employees were ultimately responsible for housekeeping.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 2/28/24, I conducted an exit conference with licensee Vicky Cates. I shared my findings and Ms. Cates agreed with the conclusions reached.
