05/16/2024- I reviewed the current license file, licensee designee's experience, licensee's information in BITS, admission policy and the revised program statement.

## IV. Description of Findings and Conclusions

Based on the information received and documents reviewed, the licensee designee, John Abbo, is qualified to provide services to residents 30 years of age and older. Mr. Abbo will conduct a thorough assessment prior to accepting residents into the home to ensure that they are compatible with the other residents at Harmony Assisted Living.

## V. Recommendation

I recommend that the minimum age range for Harmony Assisted Living be change from 65 years old to 30 years old.
