ALLEGATION:

Resident A was not receiving his medications.

INVESTIGATION:

On 3/6/24, I received an anonymous complaint alleging Resident A told complainant he does not always receive his medications.

On 3/11/24, I conducted an unannounced, onsite inspection of the home. The home is licensed for six residents there are currently four residents living there. I interviewed both Mr. Gulley, licensee, and Resident A, separately, about these allegations. Mr. Gulley told me that Resident A receives his medications as instructed. Resident A denied telling anyone he does not receive his medications and regularly receives them with no issues.

On 4/28/24, I interviewed Mr. Gulley and requested copies of Resident A's medication record.

On 4/29/24, Mr. Gulley provided several months of these records which showed that Resident A received his medications.

APPLICABLE RULE

	(2) Medication shall be given pursuant to label instructions.
ANALYSIS:	I could find no evidence to substantiate this allegation.
CONCLUSION:	VIOLATION NOT ESTABLISHED

ADDITIONAL FINDINGS:

INVESTIGATION:

On 4/10/24, I interviewed Resident B in his room and noticed his commode was full of urine and feces. Resident B told me he was not able to empty his commode himself and that Resident A was responsible for emptying it. Resident B also told me Resident A was responsible for taking out the garbage of the home.

On 4/10/24, I interviewed Resident A who told me that it is his responsibility to empty Resident A's commode and that he is the one who empties the trash for the home and carries it to the road for garbage pickup. He also told me he regularly does the dishes for the home. Resident A told me he is fine with this arrangement and that he receives compensation from licensee Gulley for performing these responsibilities.

On 4/15/24, I interviewed adult protective services (APS) worker Christina Bohen who confirmed that Resident A told her similar information.

On 4/28/24 I interviewed Mr. Gulley who reported that he and Resident A have had this agreement for a while. Resident A gets paid to do some work around the home and this allows him more money to purchase personal items for himself.

APPLICABLE RULE	
R 400.1404	Licensee, responsible person, and member of the household; qualifications.
	(2) A responsible person shall be other than a resident.

ANALYSIS:	Tasks such as emptying Resident B's commode, doing dishes, and taking out the garbage, are the responsibility of licensee Gulley and responsible person Terry Peterson. Residents of an AFC cannot be persuaded to provide care for other residents, in any capacity.
CONCLUSION:	VIOLATION ESTABLISHED

On 5/16/24, I conducted an exit conference with licensee Gulley explaining to him that there was not sufficient evidence to warrant a rule violation in regard to Resident A's medications. However, I also explained that Resident A acting as an employee around the home is a rule violation. Mr. Gulley reported that he understood.

IV. RECOMMENDATION

Contingent upon receipt of an appropriate corrective action plan, I recommend no changes to the status of this license.
