The purpose of the addendum is to add traumatically brain injured (TBI) and physically handicapped to the program type and population served.

# III. Methodology

06/14/2024 - Received corrective action plan from licensee designee, Theodora Calvas, indicating intent to modify population served by facility.

06/17/2024 - Sent information to Theodora Calvas regarding population change and requested updated program statement.

07/11/2024 - Onsite inspection. Received request to change program type, updated program statement, and verified licensee designee's experience with populations.

07/11/2024 - Reviewed documentation provided and information in BITS

#### IV. Description of Findings and Conclusions

Based on the information received, the facility is approved to admit residents who are traumatically brain injured and physically handicapped. The licensee designee/administrator, Theodora Calvas, has over one year of experience working with the physically handicapped and TBI populations in an adult foster care setting. The facility's program statement has been updated to include TBI and physically handicapped in the description of populations served. Training will be provided to direct care staff regarding the needs of the population.

#### V. Recommendation

I recommend that traumatically brain injured and physically handicapped be added to the program type and population served by Kernway Assisted Living of Bloomfield.
