## **II. Purpose of Addendum**

Olive Branch Senior Assisted Living LLC, has entered into a Management Agreement with Divine Nest of Perry 2, Inc., who will perform management services for the facility, as specified in their management agreement.

## **III. Methodology**

10/04/2024, Achal Patel submitted documentation confirming the management agreement between Olive Branch Senior Assisted Living LLC and Divine Nest of Perry 2, Inc. The agreement indicated Divine Nest of Perry 2, Inc. will provide to the facility, and it's business, management services as set forth in the agreement.

I reviewed the management agreement and determined it did not pose any obstacles to the licensee's ultimate control of the home and its operation.

The licensee understands their continual legal responsibility for the provision of adult foster care and compliance with all licensing regulations and requirements.

Both parties understand the management agreement does not abridge the licensee's rights to access and operate the home.

The department has assessed and approved the qualifications of the licensee's appointed licensee designee and administrator operating the home under a management agreement.

## **IV. Description of Findings and Conclusions**

I confirmed with Mr. Patel that the management agreement between both parties is not a "change in ownership/controlling interest". Subsequently, Olive Branch Senior Assisted Living LLC remains the licensee. Mr. Patel acknowledged the licensee maintains ultimate control of the facility and its operation.

**V. Recommendation**

I approve the management agreement between the licensee and Divine Nest of Perry 2, Inc.
