On 10/15/2024, licensee Marion Mustar made inappropriate comments towards Resident A in Licensee Mustar's approach to attempt to have Resident A follow a recommended diet and/or lose weight.	Yes

**III. METHODOLOGY**

10/16/2024	Special Investigation Intake 2025A0123005
10/17/2024	Special Investigation Initiated - Letter

10/17/2024	Contact - Telephone call made I left Complainant 1 a voicemail requesting a return call.
10/17/2024	Contact - Telephone call received I received a voicemail from Complainant 1.
10/24/2024	Contact - Telephone call made I made an attempted return call to Complainant 1.
10/25/2024	Inspection Completed On-site I conducted an unannounced on-site at the facility. I interviewed licensee Marion Mustar and Resident A.
12/02/2024	Contact- Telephone call made I attempted to contact Complainant 1 via phone. I sent a follow-up email.
12/02/2024	Contact- Telephone call received I spoke with Complainant 1 via phone.
12/02/2024	Exit Conference I spoke with licensee Marion Mustar via phone.

**ALLEGATION:** On 10/15/2024, licensee Marion Mustar made inappropriate comments towards Resident A in Licensee Mustar's approach to attempt to have Resident A follow a recommended diet and/or lose weight.

**INVESTIGATION:** On 10/16/2024, the Bureau of Community and Health Systems received the above allegations. The allegations also noted that Licensee Mustar stated "*I'd never want to weigh as much as you*", and listed off what Resident A has overeaten, why it is too much food, and that if Resident A wants to lose weight, Resident A needs to stop eating so much. Licensee Mustar was not appearing to be respecting the dignity and worth of Resident A. Licensee Mustar's methods to try and get Resident A to eat less and lose weight were more like verbal nagging and negative judgements.

On 10/25/2024, I conducted an unannounced on-site at the facility. I interviewed licensee Marion Mustar. Marion Mustar stated that Resident A has lived in the facility for about six months and was about 300 lbs. at that time. Resident A wants to be on a diet but wants to eat what Resident A wants to eat. Resident A gets argumentative about food. Maron Mustar stated that she tried explaining to Resident A the old fashion way of cutting calories, but anything that is said, Resident A takes offense. Marion. Marion Mustar admitted that her words were harsh but stated that Resident A is disrespectful. Marion Mustar stated that she did say "*I'd never want to weigh as much as you.*" Marion Mustar denied being disrespectful to Resident A's dignity and worth of Resident A as a human being.

On 10/25/2024, I interviewed Resident A at the facility. Resident A stated that they have lived in the facility for about six months. Resident A stated that they butt heads with licensee Marion Mustar a little bit, but understands Marion Mustar is trying to help Resident A. Resident A stated that they receive three meals per day but feels guilty about asking for extra food. Resident A stated that they butt heads on little things like snacks. Resident A stated that Marion Mustar will say "*You shouldn't eat this. Put it back.*" Resident A stated that they had a bariatric surgery diet and is only allowed to eat a certain amount of calories. Resident A stated they had surgery in November 2023. Resident A stated that Marion Mustar's comments are hurtful in a way because they are blunt/mean. Resident A stated that the comments are said with a stern tone. Resident A stated that food and bariatric issues are sensitive issues because Resident A has been dealing with these things for a long time. Resident A stated that they are happy with living in this facility and does not want to move to a more restrictive setting.

On 10/25/2024, during this unannounced on-site I observed five residents. They appeared clean and appropriately dressed.

On 12/02/2024, I spoke with Complainant 1 via phone. Complainant 1 stated that there have been no other issues regarding the allegations since the submission of this complaint. There was a personality clash between Licensee Marion Mustar and Resident A. Resident A was upset on 10/15/2024 but was just trying to get along

with Licensee Marion Mustar. Resident A did have bariatric surgery in the past, and Resident A has diet recommendations. The comments Licensee Mustar made to Resident A on 10/15/2024 were of a negative, shaming, and demeaning nature. Resident A provided a 30-day notice to move out and was encouraged not to talk to Licensee Mustar about their weight loss. Resident A will be moving out on 12/18/2024.

On 12/02/2024, I conducted an exit conference with licensee Marion Mustar. I informed Marion Mustar of the findings and conclusion. License Mustar stated that Resident A is moving to another home on 12/18/2024 because Resident A has health issues. Licensee Mustar stated that she and Resident A have not had any arguments regarding Resident A's diet since this complaint was submitted.

<b>ANALYSIS:</b>	<p>On 10/25/2024, I conducted an unannounced on-site at the facility. I interviewed licensee Marion Mustar. Licensee Mustar admitted to having conflict with Resident A regarding Resident A's eating habits and admitted that her words towards Resident A were harsh.</p> <p>Resident A was interviewed and reported they butt heads with Licensee Marion Mustar, and that Licensee Mustar's words have been hurtful in a way because they are mean/blunt words.</p> <p>On 12/02/2024, I spoke with Complainant 1 who stated that there have been no issues since 10/15/2024 regarding the allegations, but on 10/15/2024, the words Licensee Mustar said to Resident A were of a negative, shaming, and demeaning nature.</p> <p>There is a preponderance of evidence to substantiate a rule violation in regard to Licensee Mustar not treating Resident A with consideration and respect.</p>
<b>CONCLUSION:</b>	<b>VIOLATION ESTABLISHED</b>

**IV. RECOMMENDATION**

Contingent upon the receipt of an acceptable corrective action plan, I recommend continuation of the AFC family home license (capacity 5).




