# ALLEGATION:

An employee's husband does not meet good moral character standards.

# INVESTIGATION:

On 10/22/24, I interviewed employee Amanda Cilley in the facility. Ms. Cilley is the live in employee at the facility. Ms. Cilley advised that her husband Chance does not have an outstanding warrant for his arrest but acknowledged that he was asked not to return to their daughter's school because he had an argument with school personnel because they were not following her IEP.

On 11/14/24, I received a workforce background check letter forwarded by licensee Vicky Cates. The letter states that Chance Bishop is eligible to work at a facility.

APPLICABLE RULE	
R 400.14204	Direct care staff; qualifications and training.
	(2) Direct care staff shall possess all of the following qualifications:
	(a) Be suitable to meet the physical, emotional, intellectual, and social needs of each resident.
ANALYSIS:	A workforce background letter was provided. The letter states that Chance Bishop, Ms. Cilley's husband, is eligible to work in a facility.
CONCLUSION:	VIOLATION NOT ESTABLISHED

# ALLEGATION:

Resident A's medical condition is not properly managed.

# INVESTIGATION:

On 10/22/24, I interviewed Resident A in the facility. Resident A was observed using a walker that was designed for him to ambulate and stabilize him when he sits. He confirmed that he was in a rehabilitation facility recently but was confused about his dates of stay. He advised that he has had the walker for about a week. Resident A discussed taking medication to address medical issues.

I interviewed employee Amanda Cilley in the facility. Ms. Cilley reported that Resident A sees an occupational and a physical therapist twice a week. Ms. Cilley stated that Resident A has been back in the facility for about a month and a half. I had observed Ms. Cilley outside with Resident A when I arrived, and she was assisting him into the dining room to have lunch.

APPLICABLE RULE	
R 400.14310	Resident health care.
	(1) A licensee, with a resident's cooperation, shall follow the instructions and recommendations of a resident's physician or other health care professional with regard to such items as any of the following:
	(d) Other resident health care needs that can be provided in the home. The refusal to follow the instructions and recommendations shall be recorded in the resident's record.
ANALYSIS:	I observed Ms. Cilley supervising Resident A using his assistive device. Resident A expressed satisfaction with the facility's ability to follow his plan of care.
CONCLUSION:	VIOLATION NOT ESTABLISHED

### ALLEGATION:

Meals are not of proper consistency.

#### **INVESTIGATION:**

On 10/22/24, I interviewed Resident B in the home. Resident B stated expressed satisfaction with the food provided.

Employee Amanda Cilley provided copies of the menu. The document reflected a variety of choices that were of proper consistency. Ms. Cilley reported that breakfast typically consists of cereal or oatmeal, lunches are sandwiches or soup and they eat a large dinner.

I observed the residents eating chicken noodle soup.

APPLICABLE RULE	
R 400.14313	Resident nutrition.
	(1) A licensee shall provide a minimum of 3 regular,
	nutritious meals daily. Meals shall be of proper form,

	consistency, and temperature. Not more than 14 hours shall elapse between the evening and morning meal.
ANALYSIS:	I observed menus and meal service. A resident expressed satisfaction with the food provided.
CONCLUSION:	VIOLATION NOT ESTABLISHED

### ALLEGATION:

# Residents do not receive their money.

#### **INVESTIGATION:**

On 10/22/24, Resident A denied having issues with the home providing him with access to his funds. I observed Resident A's funds documents, and there did not reflect any issues with Resident A having access to his funds.

APPLICABLE RULE	
R 400.14315	Handling of resident funds and valuables.
	(7) A resident shall have access to and use of personal funds that belong to him or her in reasonable amounts, including immediate access to not less than \$20.00 of his or her personal funds. A resident shall receive up to his or her full amount of personal funds at a time designated by the resident, but not more than 5 days after the request for the funds. Exceptions to this requirement shall be subject to the provisions of the resident's assessment plan and the plan of services.
ANALYSIS:	Resident A's funds were reviewed, and there did not appear to be any problems with the document. Resident A also denied problems with access to his funds.
CONCLUSION:	VIOLATION NOT ESTABLISHED

#### IV. RECOMMENDATION

I recommend no change to the status of this license.
