### II. Purpose of Addendum

The purpose of the addendum is to add Alzheimer's and wheelchair accessible to the description of the home and population served.

### III. Methodology

12/19/2024	Contact - Telephone Call Received From licensee, Enyioma Uduh, requesting that the license be changed to include wheelchair accessible, as installation of the wheelchair ramp was completed at the home.
12/26/2024	Inspection Completed Onsite I conducted an onsite inspection at Rising Sun Adult Foster Care and observed the wheelchair ramp that was installed at the means of egress in the front of the house.
12/26/2024	Contact - Document Received Reviewed building permit and approval from the City of Oak Park for the ramp.
12/26/2024	Contact - Face to Face Licensee, Enyioma Uduh, requested to add Alzheimer's to the population served by the home.

# IV. Description of Findings and Conclusions

Based on the information received and my observations during the onsite inspection, the facility is equipped to admit residents who use wheelchairs. The home is equipped with a wheelchair ramp at the primary means of egress that terminates on a firm surface and allows the wheelchair occupant to move a safe distance away from the home.

The facility is also approved to admit residents who are diagnosed with Alzheimer's disease. Enyioma Uduh expressed an understanding that it is her responsibility as the licensee to conduct a thorough assessment at the time of admission to ensure that all residents are compatible with one another, and to ensure that the facility can meet their needs.

# V. Recommendation

I recommend that wheelchair accessible and Alzheimer's be added to the description of the home and population served for Rising Sun Adult Foster Care.
