## II. Purpose of Addendum

The purpose of this addendum is to document an increased resident capacity from four residents to six residents.

#### III. Methodology

December 17, 2024 – Written notice received from Licensee Katlyne Forquer-Friar informing that an additional resident bedroom was added to the facility and requesting an increase in resident capacity from the current four residents to six residents.

January 7, 2025 – On-site inspection completed.

## IV. Description of Findings and Conclusions

The facility has added an additional resident bedroom. This bedroom measures 13'10" X 11'10" or 163 square feet of resident bedroom space.

The living, dining, and sitting room areas measure a total of 263 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate 6 residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

#### V. Recommendation

I recommend the licensed resident capacity be increased to a maximum of six residents effective January 27, 2025.
