ALLEGATION:

On 12/15/2024, the home manager left the residents home alone.

INVESTIGATION:

On 01/10/2025, I made a telephone call to the program manager, Seun Olawunmi, He confirmed the allegations. He explained that the home manager, Shadreck Chindindi, left the key to the medication cabinet in the work van, which was parked at one of the licensee’s other facilities. Seun reported Shadreck was the only staff on duty at the time, and he left the facility around 6:00 a.m. to retrieve it. All the residents were sleep at the time. Resident A woke up while Shadreck was gone and called the police. Seun said Shadreck was fired immediately.

On 01/10/2025, I made a telephone call to Shadreck. He indicated he left the key to the medication cabinet in the van and the van was at the other facility. Since the residents were sleep and were going to need their morning medication when they got up and there was no other staff on duty, he decided to go get it. He said he was only gone about 10 minutes. When he returned the police was there doing a welfare check because Resident A had called them.

On 01/17/2025, I conducted an onsite inspection at the facility. Residents A-E were present and were interviewed separately. They stated this was the first time they had ever been left alone. They all spoke well of the facility and staff and stated there is always at least 1 staff present each shift. Resident A said when he woke up on 12/15/2025, he did not see anyone and was concerned so he called the police.

On 02/12/2025, I made a telephone call to the residents’ case manager, Teena Hudson, from Hegira. She stated she was aware of the incident and was surprised by it. She described the facility as being one of her best homes and stated this has never happened before.

On 02/12/2025, as requested by the licensee designee, Annett Uduji, I conducted an exit conference with the administrator, Emmanuel Uchechukwu. I informed him of my investigative findings, which he understood and said Shadreck would not be returning.

APPLICABLE RULE	
R 400.14206	Staffing requirements.
	(2) A licensee shall have sufficient direct care staff on duty at all times for the supervision, personal care, and protection of residents and to provide the services specified in the resident’s resident care agreement and assessment plan.

ANALYSIS:	Based on the information obtained during this investigation, the allegations are confirmed. There was insufficient staff on duty at all times for the supervision, personal care, and protection of the residents. Shadreck admitted to leaving the residents alone and the residents reported being left alone.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, I recommend the status of the license remains unchanged.
