III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

R 325.1970 Water supply systems.

(7) The temperature of hot water at plumbing fixtures used by residents shall be regulated to provide tempered water at a range of 105 to 120 degrees Fahrenheit.

The water temperatures in the bathroom sinks and showers of apartments 207, 304, and 404 ranged from 82.2 to 133.5 degrees Fahrenheit.

REPEAT VIOLATION ESTABLISHED.
