## **II. Purpose of Addendum**

To lower the age requirement from 40 years plus to 18 years old.

## **III. Methodology**

On 3/8/25, licensee designee, Kamita Bell submitted a modification request to have the age requirement lowered to accept adults 18 years and older for placement.

## **IV. Description of Findings and Conclusions**

On 3/8/25, Kamita Bell submitted a revised Program Statement and Admission Policy that lowers the age requirement for placement at the Humanity Outreach facility in Detroit, Michigan. Ms. Bell's goal is to expand the age group to offer placement to younger adults in need of adult foster care services. Based on these findings, the modification request is approved.

## **V. Recommendation**

I recommend the terms of the license be modified to change the age range of residents to 18 - 99 years old.
