The licensee designees hold a current variance for Rule 315.3 regarding tracking resident room and board payments. The licensee designees utilize a computerized system to track these payments. I was able to review this system today.

### III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This facility was found to be in non-compliance with the following rules:

**R 400.15407**

**Bathrooms.**

**(3) Bathrooms shall have doors. Only positive-latching, non-locking against-egress hardware may be used. Hooks and eyes, bolts, bars, and other similar devices shall not be used on bathroom doors.**

During the on-site inspection it was observed that one of the bathroom doors was not functioning as positive-latching, non-locking against-egress due to the hardware malfunctioning. This hardware will need to be replaced to correct this issue.

### IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
