ALLEGATION:

Resident A alleges that staff throws chairs at her and assault her.

INVESTIGATION:

On 6/12/2025 an APS referral was received.

On 6/12/2025 an ORR referral was made.

On 6/12/2025, I reviewed two incident reports dated 6/9/2025 regarding Resident A. Neither incident report made mention of staff or anyone throwing chairs or assaulting Resident A.

On 6/12/2025, I interviewed Resident A's guardian. She stated that she had talked to Resident A yesterday and that Resident A never said a word about any staff mistreating her. She stated that Resident A did talk to her about working outside of the facility, but she stated that Resident A needs 24/7 supervision to prevent self-harm. Finally, she stated that she does not believe Resident A's complaints about being mistreated by staff and is satisfied with her residential placement at Eisenhower Center.

On 6/13/2025, I interviewed Resident A. Just observing her she had no apparent bruises or abrasions. She recanted her allegations that staff threw chairs at her and/or assaulted her. She stated that she likes living at Eisenhower Center but wants to reside in a different building where she has friends.

On 6/13/2025, I conducted an exit conference with Daniel Bogosian.

APPLICABLE RULE	
R 400.15308	Resident behavior interventions prohibitions.
	(1) A licensee shall not mistreat a resident and shall not permit the administrator, direct care staff, employees, volunteers who are under the direction of the licensee, visitors, or other occupants of the home to mistreat a resident. Mistreatment includes any intentional action or omission which exposes a resident to a serious risk or physical or emotional harm or the deliberate infliction of pain by any means.
ANALYSIS:	Since Resident A recanted her allegations of staff throwing chairs at her and assaulting her and I found no evidence to support such allegations, as was the result from her similar complaint previously investigated in SIR2024A0575014, then the licensee did not mistreat Resident A and did not permit the administrator, direct care staff, employees, volunteers who are under the direction of the licensee, visitors, or other occupants of the home to mistreat Resident A.
CONCLUSION:	VIOLATION NOT ESTABLISHED

IV. RECOMMENDATION


I recommend no change in the license status.
