ALLEGATION:

Resident A was discharged after his hospitalization without notice.

INVESTIGATION:

On 9/3/2025, an APS referral was made. Resident A was not interviewed because he is currently hospitalized. Rhonda Cooke, licensee stated that he does not have a court appointed guardian.

On 9/4/2025, I interviewed Rhonda Cooke, licensee at her facility. She stated that on August 7, 2025 a bee infestation was discovered in the ceiling in Resident A's bedroom. She stated that on August 9, 2025 after Resident A's family members refused to allow him to reside at their private homes, she moved him to her mother's unlicensed home in Milan, MI. She stated that Resident A did not like living at the Milan, MI unlicensed facility due to his COPD and the lack of air conditioning, so he requested to be taken to the VA hospital in Ann Arbor. On August 15, 2025 Resident A was admitted to the VA hospital in Ann Arbor, where he currently resides. She

stated that although the hospital social worker requested he be discharged from the hospital to the facility, she has no vacant bedrooms and his former bedroom cannot be used due to the bee infestation in the ceiling that has not been resolved. Finally, she stated that she did not provide Resident A with a written 30 day discharge notice to date.

On 9/4/2025, I conducted an exit conference with Rhonda Cooke. She wrote, emailed and hand delivered Resident A and the VA hospital social worker his 30-day written discharge notice effective 9/4/2025.

APPLICABLE RULE	
R 400.1407	Resident admission and discharge criteria; resident assessment plan; resident care agreement; house guidelines; fee schedule; physician's instructions; health care appraisal.
	(12) A licensee shall provide a resident with a 30-day written notice before discharge from the home. The written notice shall state the reasons for the discharge. A copy of the written notice shall be sent to the resident's designated representative and responsible agency.
ANALYSIS:	Since Resident A was given verbal notice of his discharge from the facility after he was hospitalized, then Rhonda Cooke did not provide Resident A with a 30-day written notice before he was discharged from the home.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

I recommend no change in the license status.
