II. Purpose of Addendum

LARA received a request for the approval of a Management Agreement.

III. Methodology

On September 9, 2025, LARA received a request for the approval of a Management Agreement, and after reviewing the original documents, it was requested that the agreement be revised. The revised Management Agreement was received on September 17, 2025. Philip Campau, Licensee Designee for Michigan Pure, LLC DBA Jacqueline House Assisted Living 2, LLC also provided proof of training and supporting documents for the proposed administrator.

IV. Description of Findings and Conclusions

According to documents received, Jacqueline House Assisted Living 2, LLC (AS380383819) (Company) has proposed to enter into a Management Agreement with Lena Faling (Manager), who is also the Tenant/Buyer under a Commercial Lease with an Option to Purchase Agreement.

As noted in the Management Agreement, the Agreement will commence on October 1, 2025, and continue for six months. Should the Manager obtain an AFC license prior to the expiration of the six months, the agreement will automatically terminate.

Michigan Pure, LLC / DBA Jacqueline House Assisted Living 2, LLC has requested that Philip Campau remain as the Licensee Designee and that Lena Faling be appointed as the administrator for this facility. Philip Campau has been informed and acknowledged his continued legal responsibilities for the provision of AFC and compliance with all licensing regulations and requirements.

V. Recommendation

It's recommended that the proposed Management Agreement be approved.
