ALLEGATION:

Resident A was sexually assaulted by another resident at the facility.

INVESTIGATION:

On 1/21/26, I received a complaint that alleged Resident A had been sexually assaulted by another resident at the facility.

On 1/27/26, I interviewed operations manger Alicia Bowman at the facility. Resident A fell and injured several ribs earlier in January. While at the hospital Resident A reported to nursing staff that she was sexually assaulted by another resident at the facility. Law enforcement came to the facility to investigate but concluded there was no evidence to the allegation. Resident A was sexually assaulted about 20 years ago and periodically makes similar allegations.

On 1/27/26, I interviewed Resident A at the facility. Early in January she attempted to get dressed and fell off her bed, injuring her ribs. Hospital staff were wrong and she did not tell them that she was assaulted by anyone. She felt safe at the home and enjoyed living there.

APPLICABLE RULE	
R 400.671	Resident care.
	(4) A licensee shall provide supervision, protection, and personal care as specified in a resident's assessment plan. A hospice service plan, do-not resuscitate order, or any other advance directive must be included as an addendum to the resident assessment and maintained with the assessment plan in the resident's record.
ANALYSIS:	After interviewing employees as well as Resident A, I find no evidence of an assault having taken place.
CONCLUSION:	VIOLATION NOT ESTABLISHED

On 1/30/26, I explained the findings of this report to licensee designee Kerry Nyquist. She was not aware that Resident A was ever assaulted at the facility. Employees at the hospital set up an appointment for Resident A at the Women's Center in Marquette for some time in February. Ms. Nyquist will be taking Resident A to this appointment.

IV. RECOMMENDATION

I recommend no changes to the status of this license.


