On 01/24/26 staff member Marvinna Sandifer was under the influence of alcohol while being responsible for meeting residents' needs.	Yes

III. METHODOLOGY

ALLEGATION: On 01/24/26 staff member Marvinna Sandifer was under the influence of alcohol while being responsible for meeting residents' needs.

INVESTIGATION: During a renewal inspection on 01/26/26, licensee Corey Husted reported that staff member Marvinna Sandifer was allegedly under the influence of alcohol while supervising residents on 01/24/26. Mr. Husted stated that Resident A inquired about Ms. Sandifer's whereabouts, and his brother contacted staff member Kalia Greenhoe. Ms. Greenhoe went to the home and confirmed that Ms. Sandifer appeared intoxicated. Mr. Husted reported that Ms. Sandifer was terminated immediately. He was informed that this incident would lead to a formal investigation. Resident A was not interviewed during the onsite visit due to being asleep.

On 01/26/26, I conducted an exit conference with licensee designee, Corey Husted. He was informed of the investigative findings and agreed to complete a corrective action plan within 15 days of receipt of this report.

On 01/26/26, I spoke with staff member Kalia Greenhoe via phone regarding the incident on 01/24/26. Ms. Greenhoe stated that Resident A's brother contacted her to report that staff could not be located in the home. He also contacted law enforcement. Ms. Greenhoe immediately notified the owner/licensee, Mr. Husted.

According to Ms. Greenhoe, law enforcement arrived at the home and reported that staff member Marvina Sandifer smelled of alcohol. After speaking with law enforcement, Ms. Greenhoe went to the home and observed Ms. Sandifer, describing her as “belligerent, yelling, and falling over.” She confirmed that she could smell alcohol on Ms. Sandifer. Ms. Sandifer reportedly told law enforcement that she had consumed “a shot” of alcohol the previous night to celebrate her engagement. Ms. Greenhoe noted that it was approximately 3:00pm when she arrived, and Ms. Sandifer still smelled like alcohol. Ms. Greenhoe also reported that Ms. Sandifer’s fiancé was at the home to pick her up and was arrested by law enforcement after leaving the home (likely due to driving under the influence). Ms. Greenhoe confirmed that Ms. Sandifer was terminated immediately and no longer has access to the residents. No residents were harmed during this incident.

APPLICABLE RULE	
R 400.629	Direct care staff; qualifications and training
	(4) Direct care staff shall possess all of the following qualifications before working independently: (a) Be capable of meeting the physical, emotional, intellectual, and social needs of each resident. (b) Be capable of appropriately handling emergency situations.
ANALYSIS:	All parties involved confirmed that Ms. Sandifer was intoxicated while she was solely responsible for meeting the needs of all residents. Being intoxicated makes it difficult to perform her job effectively and puts all residents at risk. Therefore, there is a preponderance of evidence to support this applicable licensing rule.
CONCLUSION:	VIOLATION ESTABLISHED

IV. RECOMMENDATION

Upon receipt of an acceptable corrective action plan, I recommend no changes to the current license status.
