III. Methodology

01/15/2026	Contact- Face to face I provided technical assistance with licensee designee regarding completing thorough intake assessments to ensure all residents are compatible with one another.

01/22/2026	Reviewed educational/experience documentation in Sharepoint, including the admission policy provided by the licensee designee.
01/22/2026	Contact- Document sent I sent an email to licensee designee, Shannon White-Schellenberger, requesting an updated admission policy and program statement.
01/26/2026	Contact- Document received I received, via email, the updated admission policy and program statement from licensee designee, Shannon White-Schellenberger.

IV. Description of Findings and Conclusions

Based on the information received, the facility is approved to admit residents aged 26 and over who are developmentally disabled. The facility is approved to admit residents in wheelchairs.

The licensee designee, Shannon White-Schellenberger, provided verification that she has over one year experience working with individuals who are developmentally disabled. Ms. White-Schellenberger earned her Bachelor of Health Science degree in 1993, and she earned a master's degree in public administration in 2002. Ms. White-Schellenberger began providing services to this

population in 1994, while working as a home manager/case manager for individuals with developmental disabilities until she was hired as the program director of Angels' Place in 2002. She was promoted to director of program services in 2015, chief program officer in 2018, and chief operating officer in 2025. Ms. White-Schellenberger expressed an understanding that it is her responsibility as the licensee designee to conduct a thorough assessment at the time of admission to ensure that all residents are compatible with one another, and to ensure that the facility can meet their needs. Ms. White-Schellenberger is the licensee for multiple homes under the Angels' Place LLC, most of them holding special certifications for developmental disabilities. She is aware of the requirements of maintaining a special certification.

V. Recommendation

I recommend issuing a special certification for the developmentally disabled population for Hylane Home.
